Application is hereby made to permit the erection of a memorial with the request that you construct a foundation of the following location:

and to permit the monument dealer who signs this application to furnish the memorial in accordance with the rules and regulations of the Cemetery. THIS MEMORIAL WILL HAVE A ROMAN CATHOLIC EMBLEM ON IT IN A PROMINENT POSITION AND IT WILL NOT HAVE ON IT ANY EMBLEM, INSIGNIA OR INSCRIPTION INCONSISTENT WITH ROMAN CATHOLIC DOCTRINE AND PRACTICE. IT IS UNDERSTOOD THAT ALL MEMORIAL WORK IS SUBJECT TO ALL THE RULES OF THE CEMETERY IN ANY WAY AFFECTING MONUMENTS, MARKERS, HEADSTONES OR ANY OTHER STRUCTURES OR MEMORIALS, THEIR MANUFACTURE, LOCATION, CARE, ERECTION, REMOVAL OR IN ANY OTHER REGARD, SUBJECT TO ALL OTHER RULES AND REGULATIONS OF THE CEMETERY NOW IN FORCE OR HEREAFTER ADOPTED.

Should any memorial, in the opinion of the Cemetery Authorities, become unsightly, dilapidated or dangerous to visitors, it is understood that the Cemetery shall have the right either to correct the condition or to remove the same at the expense of the lot owner or his or her heirs, after giving due notice in writing to the last known address of the lot owner on file in the Cemetery Office.

The undersigned who represents that he, she, or they, is or are the sole and exclusive owner or owners of the right of sepulture in the grave or lot described above hereby authorizes and request the Superintendent of the above-mentioned Cemetery to permit the erection of the memorial as described on the reverse side of this application, and the construction of a foundation, if necessary, and does hereby agree to all the terms, conditions and other provisions as set forth on both sides of this application.

In the event of this application being signed by an agent of the Plot Holder the agent agrees to inform the Plot Holder of the provisions of this agreement and the rules and regulations of the Cemetery governing memorial work.

MONUMENT DEALER AGREEMENT

I certify that I have been authorized by the person making this application to prepare a memorial for the above-described location and that the reverse side of this agreement contains the specifications and detailed sketch of this memorial.

I certify that this memorial is made entirely of first-grade material (as defined in the Manufacturer's and Quarrier's Agreement (herein) and guaranteed by me to be free from all flaws, defects and toll marks and that the workmanship on said memorial will be the highest standard. Should a defect in material or workmanship become apparent before the lapse of five years from date of setting, the Cemetery Authorities shall make such a declaration in writing to the monument dealer and the memorial will be replaced without cost to the Cemetery.

I hereby abide by the rules and regulations of the Cemetery now in force or hereafter adopted, in the erection of the memorial work in the above-mentioned Cemetery, and further agree that, if in the opinion of the Cemetery Authorities should the completed memorial not comply with said rules and regulations, it will, at the request of the Cemetery Authorities, be removed by me within three days of such request, without cost to the Cemetery or the Plot Holder.

The undersigned further agrees to hold the Cemetery free from any liability whatsoever for damage to the memorial that may result from the installation of said memorial, before, during or after the setting of said memorial.

I hereby agree to pay for any damage to lots, graves, walks, trees, shrubs, memorials, etc., during the transportation and setting of this memorial. I hereby agree to indemnify, defend and save harmless the Cemetery upon, or from, any and all claims, demands or alleged causes of action arising by reason of the erection of said memorial.

No memorial, once erected, may be removed from the Cemetery without written permission of the Cemetery Authorities.

No tools, equipment, structure, etc., required in the erection of the memorial may be left overnight in the Cemetery without the written permission of the Superintendent of the Cemetery.

Acceptance of this permit by the Cemetery and the payment for foundation charges or other payments do not constitute complete approval of this application.

MANUFACTURER AND QUARRIER AGREEMENT

The undersigned producer of monumental materials, whether a manufacture of memorials or a quarrier, or a quarrier who also manufactures materials, agrees to provide only first grade, clear stone for memorial purposes and hereby guarantees that such stone is free from sap or anything which will cause rust stains and guarantees that such stone will not check or crack and further agrees that should such faults develop within five years from the date of setting, the memorial will be replaced without cost to the Cemetery, or lot owner, by such quarrier so manufacturing said memorial, or by the manufacturer thereof who will look to his quarrier for adjustment on material, such adjustment not to delay the replacement of memorial in the Cemetery.
